入学料及び授業料特別免除制度について

このことについて、本学大学院総合理工学研究科博士後期課程では、私費外国人留学生の合格者の中から入試成績等優秀者に対して、下記のとおり入学料・授業料特別免除を行います。

本制度による特別免除を希望する者は、受験する入試出願時に別紙「入学料・授業料特別免除意思確認書」を提出してください。(ホームページから各自で別紙をダウンロードしてください。)

1. 目的

優秀な外国人留学生を戦略的に支援し、受入れることによって、大学の国際化を促し、教育・研究力を向上させるとともに、学生間の交流を通じてグローバル化の推進に効果を期待するもの。

2. 対象者及び人数

私費外国人留学生合格者の中から若干名

3. 選考方法

出願時に「入学料・授業料特別免除意思確認書」を提出した私費外国人留学生で入学者選抜試験合格者のうちから入学者選抜試験の成績、修士論文の概要・研究経過報告書、研究業績調書(その1)、研究業績調書(その2)及び研究計画書の内容を総合的に審査して行う。

4. 結果通知

特別免除制度適用候補者には、合格通知時に特別免除申請書類を同封する。

5. 免除期間等

- (1) 免除期間：原則として入学時から3年間とする。ただし、2年次以降については、別に定める基準により特に学業が優秀と認められた場合に当該年次分の授業料を免除する。なお、ただし書きの基準により、特に学業が優秀と認められなかった場合には、特別免除の資格を喪失し、当該年次以降の授業料特別免除を行わない。
- (2) 継続要件：2年次以降の授業料特別免除は、原則として、2年次生にあつては、1年次の成績及び研究状況、3年次生にあつては、2年次の成績及び研究状況により博士後期課程専攻代表者会議により審査する。

RE: A Special Exemption of Entrance and Tuition Fees Applicable to the Private Expense Foreign Students Who Have Achieved Excellent Results in the Entrance Examination at the Doctoral Degree Course in the Interdisciplinary Graduate School of Science and Engineering

There is special exemption of the admission and tuition fees at our Doctoral Degree Course in the Interdisciplinary Graduate School of Science and Engineering. This exemption is applicable to the private expense foreign students who will be admitted to the University with excellent results. The following is the detailed information.

Those who wish to apply for the exemption are requested to submit the separate form "Letter of Intent for Special Exemption of Entrance and Tuition Fees for Examinees of the Doctoral Degree Course of the Interdisciplinary Graduate School of Science and Engineering, Shimane University (Private Expense Foreign Students)" together with the application for admission. (The applicants can download the "Letter of Intent for Special Exemption of Entrance and Tuition Fees for Examinees of the Doctoral Degree Course of the Interdisciplinary Graduate School of Science and Engineering, Shimane University (Private Expense Foreign Students)" form from our Homepage).

Note

1. Purpose

It is our hope that by matriculating and supporting excellent foreign students strategically, the globalization of the university will be promoted and at the same time, education and the sustainable research activities will be enriched. Further, by making cultural exchange among these students, the advancement of the globalization will be encouraged.

2. Qualification for Application and the Number of the Grantees

Qualification for Application: Private-expense foreign students
who passed the entrance examination
Number of the Grantees: Several

3. Selection Process

Selection is to be made as follows:

Among those Private-expense foreign students who passed the entrance examination and submitted the form " Letter of Intent for Special Exemption of Entrance and Tuition Fees for Examinees of the Doctoral Degree Course of the Interdisciplinary Graduate School of Science and Engineering, Shimane University (Private Expense Foreign Students)", the screening will be made according to the comprehensive judgment. The screening subjects are "The Result of the Entrance Examination", "The Resume of Master Course Thesis", "The Report of the Research Progress", "The Record of the Research Achievement (1)", "The Record of the Research Achievement (2)", and "The Research Plan".

4. Announcement of the Result

The prospective students will receive the enclosed "Application for the Special Exemption of Entrance and Tuition Fees" form together with the notification of acceptance.

5. Terms of the Exemption, etc.

(1) Basically, the term of the exemption is three years right after entering the University. However, as for the second year on and after, the system will be applied only to the students who achieve the excellent results on their academic performances. According to the criterion of provisory clause, in case the students' academic performances are not admitted as superior, the students will lose the qualification and will not be able to get the exemption hereafter.

(2) Requirement for the Exemption Renewal

Basically, on and after the second year, the qualification of the exemption will be judged by the students' academic performance results and the research performances of the first year for the second year students, and by those of the second year for the third year students. The exemption will be judged by our Special Faculty Members Council in the Doctoral Degree Course.
